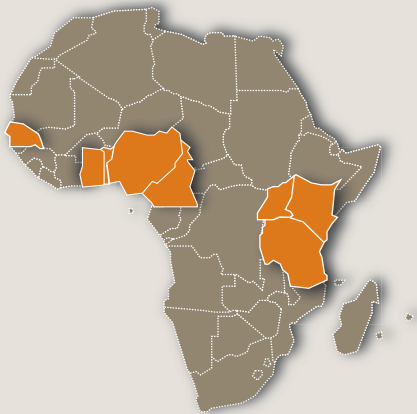

#### TA Facility Manager Comment

The REGMIFA TA Facility was officially launched on 1 January 2011. During the first months of operations, a strong focus was given to the finalization of the legal agreements with the contributors, the drafting of template contracts for the consultants and the PLIs and the approval of the Operational Documents.

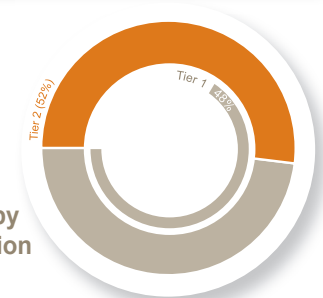
