TA Facility Manager Comment

Within the reporting quarter four projects were approved supporting the institutions in SME Lending, Liquidity and Treasury Management, Corporate Governance Training and Deposit Mobilization trough new processes and technologies.

Five contracts were concluded in the reporting quarter. Currently there are 10 projects ongoing and therefore under monitoring.

In Q3 seven projects came to completion in line with the agreed timing and deliverables. In one case the project experienced a slight delay in the delivery of all services due to external circumstances. The completed projects received an excellent feedback from the PLIs on the quality of consulting services delivered.

The strong pipeline (with currently 10 projects in progress) gives a very positive outlook on the coming months for the operational activity of the TA Facility.


